## NOTIFICATION

In exercise of the powers conferred by section 41 of the Rajasthan Excise Act, 1950 (Act No. II of 1950), the State Government hereby makes the following rules further to amend the Rajasthan Excise (Grant of Hotel Bar/Club Bar Licences) Rules, 1973 and orders with reference to the proviso to sub-section (3) of the said section that previous publication of these amendment rules is dispensed with as the State Government considers that they should be brought into force at once, namely:-

- 1. Short title and commencement.— (1) These rules may be called the Rajasthan Excise (Grant of Hotel Bar/Club Bar Licences) (Amendment) Rules, 2018.
- (2) They shall come into force at once.
- 2. Amendment of rule 3.— In rule 3 of the Rajasthan Excise (Grant of Hotel Bar/Club Bar Licences) Rules, 1973, the existing sub-rule (11) shall be substituted by the following, namely:-
  - "(11) The District Excise Officer concerned, after satisfying himself that the minimum fee has been deposited into the Treasury shall inspect the location of the premises where the foreign liquor shall be stored and the counter where it shall be sold and submit his report to the Excise Commissioner who may issue the licence accordingly, under his signature and the seal of his office in Form 'C' or in Form 'D' or in Form 'E', as the case may be:

Provided that the Excise Commissioner may sanction more than one bar counters for hotels of any star category or any other hotel having more than fifty rooms or club bar having more than two hundred fifty members registered on payment of ten percent amount of initial fee or renewal fee as the case may be for each additional bar counter and may also allow facility of room service of liquor and beer to their resident guests in refrigerators installed in let out rooms of hotel on payment of one percent amount of initial fee or renewal fee as the case may be."
