## NOTIFICATION

In exercise of the powers conferred by section 41 of the Rajasthan Excise Act, 1950 (Act No. II of 1950), the State Government hereby makes the following rules further to amend the Rajasthan Excise Rules, 1956 and orders with reference to the proviso to sub-section (3) of the said section that the previous publication of these amendment rules is dispensed with as the State Government considers that they should be brought into force at once, namely:-

- 1. Short title and commencement.- (1) These rules may be called the Rajasthan Excise (Amendment) Rules, 2021.
- (2) They shall come into force at once.
- 2. Amendment of rule 48.- In rule 48 of the Rajasthan Excise Rules, 1956, hereinafter referred to as the said rules,-
  - (i) in clause (f), the existing expression "and" shall be deleted;
  - (ii) in clause (g), for the existing expression "wine,", the expression "wine, and" shall be substituted; and
  - (iii) after the clause (g) so amended, the following new clause (h) shall be added, namely:-
    - "(h) Composite shop licenses for selling country liquor, foreign liquor and beer by retail off on the same premises."
- 3. Amendment of rule 49.- After the existing sub-rule (2) of rule 49 of the said rules, the following new sub-rule (3) shall be added, namely:-
  - "(3) Composite shop license for selling of country liquor, foreign liquor and beer by retail off on the same premises."
- **4. Amendment of rule 67-I.-** After the existing sub-rule (3) of rule 67-I of the said rules, the following new sub-rule (4) shall be added, namely:-
  - "(4) Composite shop license for exclusive privilege of selling country liquor, foreign liquor and beer by retail off on the same premises within any local area under section 24 may be granted on the condition of such separate lump-sum for country liquor, foreign liquor and beer instead of, or in addition to excise duty as may be determined by the Excise Commissioner and subject to such other terms and conditions as may be laid down by him."
  - 5. Amendment of rule 68.— In the table appearing below rule 68 of the said rules,-

- 9. Amendment of rule 74.- In rule 74 of the said rules,-
  - (i) existing clause (iii) shall be substituted by the following, namely:-
    - "(iii) No person shall hold or have an interest in more than two shops in any district and five shops in the State for the retail sale of the same Excisable article,"; and
  - (ii) after the existing clause (v), the following new proviso shall be added, namely:"Provided that the provisions of this rule shall not be apply in case of RSGSM and RSBCL."
