### Order

Subject: Regarding requirement of mandatory prior registration of bidders from the countries sharing land border with India-Restrictions under Rule 13 of the Rajasthan Transparency in Public Procurement Rules, 2013

Attention is invited to the FD Notification of even no. dated 01.01.2021 vide which amendment in Rule 13 of the Rajasthan Transparency in Public Procurement (RTPP) Rules,2013 was made. The above mentioned notification was issued in compliance of Order F.No.6/18/2019-PPD dated 23<sup>rd</sup> July 2020, issued by Public Procurement Division, Department of Expenditure, Ministry of Finance, Government of India, New Delhi In this regard, the following is hereby ordered on the grounds stated therein:

### Requirement of registration

- 1. Any bidder from a country which shares a land border with India will be eligible to bid in any procurement whether of goods, services (including consultancy services and non-consultancy services) or works (including turnkey projects) only if the bidder is registered either with the Competent Authority of Gol by Department of Promotion of Industries and internal trade under the Ministry of Commerce and Industry or with the Competent Authority of GoR (constituted as per **Annexure-I**).
- **2.** Applicability:-This order shall be applicable to all the procuring entities referred to in the sub-section (2) of section 3 of RTPP Act,2012:-
  - (a) any department of the State Government or its attached or subordinate office;
  - (b) any State Public Sector Enterprise owned or controlled by the State Government;
  - (c) any body established or constituted by the Constitution whose expenditure is met from the Consolidated Fund of the State;
  - (d) any body or board or corporation or authority or society or trust or autonomous body (by whatever name called) established or constituted by an Act of the State Legislature or a body owned or controlled by the State Government;

(e) any other entity which the State Government may, by notification, specify to be a procuring entity for the purpose of this Act, being an entity that receives substantial financial assistance from the State Government in so far as the utilization of such assistance towards procurement is concerned.

Notwithstanding anything contained in above, the provisions of this order shall apply to a procuring entity subject to any obligation of the State Government under or arising out of any agreement entered into by the Central Government with any other country or with an intergovernmental international financing institution and the requirements of such agreement shall prevail over the provisions of this order.

- 3. This Order shall not apply to-
  - cases where orders have been placed or contract has been concluded or letter/notice of award/ acceptance (LoA) has been issued on or before the date of this order; and
  - (ii) cases falling under the following special cases:-
    - (a) Bonafide procurements made through GeM without knowing the country of the bidder till the date fixed by GeM for this purpose, shall not be invalidated by this Order.
    - (b) Bonafide small procurements, made without knowing the country of the bidder, shall not be invalidated by this Order.
    - (c) In projects which receive international funding with the approval of the Department of Economic Affairs (DEA), Ministry of Finance, the procurement guidelines applicable to the project shall normally be followed, notwithstanding anything contained in this Order and without reference to the Competent Authority. Exceptions to this shall be decided in consultation with DEA.
- 4. Bids where no contract has been concluded or no LoA has been issued so far shall be handled in the following manner:
  - a) In bids which are yet to be opened, or where evaluation of technical bid or the first exclusionary qualificatory stage (i.e., the first stage at which the qualifications of bids are evaluated and unqualified bidders are excluded) has not been completed: No contracts shall be placed on bidders from such countries, bids received from bidders from such countries shall be dealt with as if they are non-compliant with the bid conditions and the bid shall be processed accordingly.

b) If the bidding process has crossed the first exclusionary qualificatory stage: If the qualified bidders include bidders from such countries, the entire process shall be scrapped and initiated de novo. The de novo process shall adhere to the conditions prescribed in this Order.

**Clarification:**- It is hereby clarified that for the purpose of paragraph 4 (b), "qualified bidders" means only those bidders who would otherwise have been qualified for award of the bid after considering all factors including price, if the Gol Order (Public Procurement No. 1) dated 23<sup>rd</sup> July 2020 had not been issued.

If the bidders from such countries would not have qualified for award for reasons unconnected with the said Order (for example, because they do not meet bid criteria or their price bid is higher or because of the provisions of purchase preference under any other order or rule or any other reason) then there is no need to scrap the bid / start the process de novo.

The following examples are given to assist in implementation of the Order-

**Example 1**: Four bids are received in a bid process. One of them is from a country which shares a land border with India. The bidder from such country is found to be qualified technically by meeting all prescribed criteria and is also the lowest bidder. In this case, the bidder is qualified for award of the bid, except for the provisions of the Gol Order (Public Procurement No. 1) dated 23<sup>rd</sup> July, 2020. In this case, the bid should be scrapped and fresh bid initiated.

**Example 2:** The facts are as in Example 1, but the bidder from such country, though technically qualified is not the lowest because there are other technically qualified bidders whose price is lower. Hence the bidder from such country would not be qualified for award of the bid irrespective of the Gol Order (Public Procurement No. 1) dated 23<sup>rd</sup> July 2020. In such a case, there is no need to scrap the bid.

**Example 3**: The facts are as in Example 1, but the bidder from a country which shares a land border with India, though technically qualified, is not eligible for award due to the application of price preference as per other orders /rules. In such a case, there is no need to scrap the bid.

**Example 4**: Three bids are received in a bid process. One of them is a bidder from a country sharing a land border with India. The bidder from such a country does not meet the technical requirements and hence is not qualified. There is no need to scrap the bid.

#### Incorporation in bid conditions

5. In bids to be issued after the date of this order, the provisions of paragraph-1 and of other relevant provisions of this Order shall be incorporated in the bid conditions.

### Certificate regarding compliance

6. A certificate shall be taken from bidders in the bid documents regarding their compliance with this Order. If such certificate given by a bidder whose bid is accepted is found to be false, this would be a ground for immediate termination and further legal action in accordance with law.

### Validity of registration

7. In respect of bids, registration should be valid at the time of submission of bids and at the time of acceptance of bids. In respect of supply otherwise than by bid, registration should be valid at the time of placement of order. If the bidder was validly registered at the time of acceptance / placement of order, registration shall not be a relevant consideration during contract execution.

# Competent Authority and Procedure for Registration

### Requirement of Registration

Any bidder from a country which shares a land border with India will be eligible to bid in any procurement whether of goods, services or works only if the bidder is registered either with the Competent Authority of GoI or with the Competent Authority of GoR. The procedure for the registration in the state would be as under-

### **Procedure for Registration**

- A. The registration would be done by Industries Department, GoR.
- B. The Registration Committee shall have the following members:-
  - (i) Principal Secretary, Industries Department, shall be the Chairman;
  - (ii) Commissioner, Department of Industries and Joint Secretary (CSR)-Member Secretary;
  - (iii) Director MSME-Development Institute, GoI, Jaipur- Member;
  - (iv) Chief Engineer, Public Works Department, or his Nominee, Not below the rank of Superintending Engineer-Member;
  - (v) Financial Advisor, Department of Industries, as a representative of Finance Department-Member;
- C. Industries Department, Government of Rajasthan shall comply the method of application. (format as per Annexure-II)
- D. On receipt of an application seeking registration from the applicant, the Industries Department shall first seek political and security clearances from the Ministry of External Affairs, GoI, New Delhi and Ministry of Home Affairs, GoI, New Delhi as per guidelines issued from time to time. Registration shall not be given unless political and security clearance have both been received.
- E. The decision of the Industries Department, to register such bidder may be for all kinds of bids or for a specified type(s) of goods, services or works and may be for a specified or unspecified duration of time, as deemed fit. The decision of the Industries Department shall be final.
- F. The Industries Department is empowered to cancel the registration already granted if it determines that there is sufficient cause. Such cancellation by itself, however, will not affect the execution of contracts already awarded. Pending cancellation, it may also suspend the registration of a bidder, and the bidder shall not be eligible to bid in any further bids during the period of suspension.

- G. Reasons of rejection of registration application submitted by a bidder are as under-
  - (a) National security reasons
  - (b) Incomplete applications
  - (c) Shortage of documents
  - (d) If debarred/blacklisted/banned by any government entity of India.
- H. In transitional cases, where it is felt that it will not be practicable to exclude bidders from a country which shares a land border with India, a reference seeking permission to consider such bidders shall be made by the procuring entity to the Industries Department, giving full information and detailed reasons. The Industries Department shall decide whether such bidders may be considered, and if so shall follow the procedure laid down in the above paras.
- I. Quarterly reports on the acceptance/refusal of registration during the preceding period may be required to be sent to the Finance Department GoR.

#### Note:

- 1. Registration granted by the Industries Department, Government of Rajasthan shall only be valid for procurement by the Government of Rajasthan and its agencies/public enterprises etc.
- 2. Registration granted by the Competent Authority of the Government of India shall be valid not only for Procurement by Central Government and its agencies/public enterprises etc. but also for procurement by State Governments and their agencies/public enterprises etc. No fresh registration at the State level shall be required for such cases.
