The Committee may invite any Government Official/Non Government person(s) for consultations and suggestions.


The Committee will make its recommendations keeping in view the following:

2. Assessing state schemes with a view to explore redundancy, overlaps and avoidable/wasteful expenditure and to suggest remedial measures;
3. Manpower assessment to suggest rational deployment;
4. Revenue expenditure rationalization with optimum resource utilization;
5. Suggestions on adoption of best practice in expenditure management.

The Committee will devise suitable procedures on its own to facilitate finalization of its report(s). It may call for such information and examine different departments and other organizations as it may consider necessary.

The Finance (Expenditure) Department will be the Administrative Department of this Committee.


The Committee may submit its interim part reports from time to time and the final report shall be furnished within 6 month.
