ORDER

The Governor is pleased to order that the following amendments are hereby made in the Public Works Financial & Accounts Rules Part-II, Appendix - XVI, namely 'Rules for Enlistment of Contractors in the Public Works Departments' :

1. The existing Rule I.2 of Section I - General Conditions, shall be substituted as under :

"I.2 The application form can be obtained from enlisting authority on non-refundable cash payment of Rs. 300/-."

2. The existing Rule II.4 of Section II - Civil Contractors, shall be substituted as under :

"II.4 Registration (Enlistment) fee and Security Deposit for Enlistment : Contractors desiring enlistment in any class shall pay Registration Fee (non-refundable) as mentioned in column 3 and Security Deposit as mentioned in column 4 of following table alongwith the application form (RPWA 108).

"III.4 Registration (Enlistment) Fee and Security Deposit for Enlistment : Contractors for furniture & joinery works desiring enlistment in any class would have to pay Registration Fee (non-refundable) as mentioned in column 3 and deposit of Security Deposit as mentioned in column 4 of following table alongwith the application form (RPWA 108).



"VI.4 Registration (Enlistment) Fee and Security Deposit for Enlistment : Contractors for painting works desiring enlistment in any class would have to pay Registration Fee (non-refundable) as mentioned in column 3 and deposit of Security Deposit as mentioned in column 4 of following table alongwith the application form (RPWA 108).


