NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and rule 21C of the Rajasthan Service Rules, 1951, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Government Servants' General Provident Fund Rules, 1997, namely:—

1. Short title and commencement.- (1) These rules may be called the Rajasthan Government Servants' General Provident Fund (Amendment) Rules, 2017.

(2) They shall come into force with immediate effect.

2. Amendment of rule 4.- The existing sub-rule (2) of rule 4 of the Rajasthan Government Servants' General Provident Fund Rules, 1997, shall be substituted by the following, namely :-

"(2) Withdrawal of any amount shall be permitted from the account, as and when required. There shall be no lock-in period."

3. Amendment of rule 14.- The existing sub-rule (2) of rule 14 of the said rules shall be substituted by the following, namely :-

"(2) The account holder and the retired Government Servant who continues his/ her account under rule 4 after his/her retirement, shall be paid interest at such rates as may be notified by the State Government, from time to time."
