Sub : Payment of fee to a Government servant holding additional charge of a post under Autonomous body in addition to duties of a post under Government

In supersession of Finance Department Memo even number dated 09.09.2005, the Governor has been pleased to order that payment of remuneration to a State Government servant who is required to hold additional charge as Administrator of Krishi Upaj Mandi Samiti or as Chairman of Urban Improvement Trust or incharge of any other Autonomous body etc. except a cooperative institution/ bank may be allowed a 'Fee' Rs. 1200/- p.m., for the actual period of holding additional charge irrespective of any time limit.

When a State Government servant is appointed to hold additional charge of more than one post under public sector undertakings or autonomous bodies in addition to his own duties under the Government at one and the same time, he shall be allowed fee in respect of only one such additional assignment.

The amount of 'Fee' payable to a Government servant for the aforesaid purpose shall be exempted from the operation of Rule 47 of Rajasthan Service Rules.


