ORDER

Sub: Ex-gratia grant to the family of volunteer home guard / civil defence who dies on election duty / other duty or sustains permanent disability while on election duty.

In supersession of all the orders issued regarding ex-gratia grant to the family of volunteer home guard / civil defence who dies on election duty / other than election duty or sustains permanent disability while on election duty, the Governor is pleased to order that the following new guidelines shall be applicable for the grant of ex-gratia subject to the condition that there should be a direct connection between occurrence of death/ permanent disability and the election duty :

- (i) On permanent disability / death while on election duty ex-gratia grant shall be made to the volunteer / next of kin of deceased volunteer;
- (ii) On death while on other than election duty ex-gratia grant shall be made to widow / widower / minor children of volunteer.

2. Amount of Ex-gratia and Circumstances :

(1) In case of death on election duty :-

S. No.	Circumstances	Amount of Ex-Gratia grant
1.	In the unfortunate event of death of the official while on election duty.	Rs 10 Lac
2.	If the death is caused due to any violent acts of extremist or unsocial elements like, road mines, bomb blasts, armed attacks, etc. of the official while on election duty.	Rs 20 Lac

(2) In case of permanent disability on election duty :-

S. No.	Kind of Mishaps	Amount of Ex-Gratia grant
1.	Permanent disability like loss of limb, eye sight etc. in normal conditions while performing election related duties.	Rs 5 Lac
2.	Permanent disability like loss of limb, eye sight etc., while performing election related duties, if caused due to any violent act of extremist or unsocial elements like road mines, bomb blasts, armed attacks etc.	Rs 10 Lac

(3) In case of death other than election duty :-

S. No.	Circumstances	Amount of Ex-Gratia grant
1	Who dies while on duty in circumstance mentioned in clause (a) to (d) of sub-rule (1) of Rule 75 or Rule 76 of Rajasthan Civil Services (Pension) Rules, 1996.	Rs 20 Lac

3. In the case of death while on election duty the Collector of the District shall be competent to grant ex-gratia to the next of kin of volunteer home guard / civil defence.
4. In the case of permanent disability while on election duty the Collector of the District shall be competent to grant ex-gratia to the volunteer home guard / civil defence.
5. The application for ex-gratia grant shall be made in the prescribed Form 17 or 17A appended to rule 75 of Rajasthan Civil Services (Pension) Rules, 1996.
6. The expenditure on account of ex-gratia granted by the Collector of the District shall be charged to the Budget Head of the Election.
7. In the case of death in other than election duty, the ex-gratia grant shall be made to the widow / widower / minor children of the deceased volunteer Home Guard/ Civil Defence who dies while on duty in the circumstances mentioned in clauses (a) to (d) of sub rule (1) of rule 75 or under rule 76, and shall be granted by the Director General, Home Guard / Director, Civil Defence on fulfillment of the conditions mentioned in the rules. The payment shall be made to the widow / widower / minor children of the deceased. Application for the same shall be submitted by the person eligible to receive the grant to the Director General, Home Guard / Director, Civil Defence. The amount shall be drawn by the Director General, Home Guards / Director, Civil Defence from the Treasury on a simple receipt form on the basis of sanction issued and shall be debited to the Budget Head to which the allowances paid to volunteer Home Guard / Civil Defence are debited.
