NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan is pleased to make the following rules further to amend the Rajasthan Civil Services (Medical Attendance) Rules, 2013, namely:-

1. Short title and commencement. - (1) These rules may be called Rajasthan Civil Services (Medical Attendance) (First Amendment) Rules, 2016.

(2) They shall come into force with immediate effect.

2. Amendment of rule 6.- In sub-rule (2) of rule 6 of the Rajasthan Civil Services (Medical Attendance) Rules, 2013, hereinafter referred to as the said rules, -

(i) in clause (l), for the existing punctuation mark “.”, appearing at the end, the expression “; and” shall be substituted.

(ii) after the existing clause (l), so amended, the following new clause (m) shall be added, namely:-

“(m) cost of specific procedure included in Panchkarma for specific diseases to the extent indicated in Appendix-XVII.”

3. Addition of new Appendix–XVII.- After the existing Appendix–XVI appended to the said rules, the following new Appendix-XVII shall be added, namely:-

Note: 1. More than one cycle shall be allowed only on the recommendation of a Medical Board comprising of following, namely:-

- (i) District Ayurveda Officer, Chairman;
- (ii) Senior Ayurveda Officer, Member; and
- (iii) Ayurveda Officer (Panchkarma Specialist), Member.

2. Cost of Ayurvedic drugs and medicines shall be reimbursable as per clause (b) of sub-rule (2) of rule 6.”
