ORDER

Sub: Amendment in Rajasthan Civil Services (Medical Attendance) Rules, 2013, Appendix- XI:- Extent of Reimbursement for treatment taken in Approved Hospital within the State

In exercise of the powers conferred under Rule 4 of Rajasthan Civil Services (Medical Attendance) Rules, 2013 and as per decision of the Health Benefit Empowered Committee (HBEC), Appendix-XI to these rules is substituted as follows:-

**Appendix – XI
(Rule-7)**

Extent of Reimbursement for treatment taken in Approved Hospital within the State

1. The reimbursement of bills of treatment taken in Approved Hospital shall be 80% of CGHS, Jaipur rates or actual being charged by the Approved Hospital, whichever is less.
2. In case of indoor treatments for which package rates are not provided in CGHS, Jaipur list, reimbursement shall be done as per the formula given in the 'Table' below.
3. The CGHS rates shall be valid for a period of 7 days after the procedure or till the date of shifting from ICU, whichever is later. For the rest period and follow up treatment, the reimbursement will be as per the formula given in the 'Table' below.

S. No.	Item	Extent of Reimbursement (Rs)
1.	Drugs & Medicines	90% of reimbursable drugs and Medicines.
2.	Investigation	1. Rates as per Appendix -XVI 2. If rates are not prescribed in Appendix -XVI , 70% of actual expenditure
3.	Operation Theatre Charges	50% of actual expenditure subject to maximum of Rs 5000/-
4.	Anesthesia Charges	50% of actual expenditure subject to maximum of Rs 5000/-
5.	Doctors Fees	Rs.400/- per day or actual whichever is less subject to the maximum limit of Rs.20,000/-*
6.	Room Charges	As per Appendix-XV
7.	Blood bank Charges including blood platelets / plasma, radiation charges etc.	As per Appendix-XVI
8.	Dialyses Charges	As per Appendix-XVI
9.	Thalassemia Major	At the rate approved under CM Relief Fund upto the extent of Rs 7 lacs.



- Note:** (1) Patient suffering from Kidney diseases should be allowed dialysis and other treatment charges in case of day care admission treatment also.
- (2) In case of outdoor treatment Rs. 50/- or actual expenses whichever is less shall be reimbursable for registration fees / consultation fees.
- (3) Medical reimbursement for following treatments of Thalassemia Major in approved private hospitals shall be limited to actual expenses or to the extent as given below, whichever is less:

S. No.	Item	Extent of Reimbursement (Rs.)
1	Autologous Blood Transfusion	4,00,000
2	Allogeinic Marrow Transplantation	7,00,000

- (4) Reimbursement for specific treatments (included in Appendix-X (a)) taken in approved private hospitals shall be limited to the actual expenses or to the extent given in Appendix-X (a) to these rules whichever is less"
4. These provisions shall be applicable from 27-06-2015. However, settled cases shall not be re-opened.
5. The provisions of this Order shall also be applicable to the State pensioners.
