ORDER

Sub: Maximum chargeable rates for treatment of Members and Ex-Members of Rajasthan Legislative Assembly in Approved Hospitals within the State

State Government vide order of even number dated 27.06.2015 has adopted the rates of CGHS, Jaipur, as may be amended from time to time, as the maximum chargeable rates for various treatments, investigations and implants etc. which can be charged by Approved Hospitals within the State for treatment of government servants covered under Rajasthan Civil Services (Medical Attendance) Rules, 2013.

Members and Ex-Members of Rajasthan Legislative Assembly are entitled to facilities of medical attendance and treatment in Rajasthan Legislative Assembly Members (Medical Facilities) Rules, 1964 and Rajasthan Legislative Assembly Ex-Members and Family Pensioners (Medical Facilities) Rules, 2010 respectively as per the provisions of Rajasthan Civil Services (Medical Attendance) Rules, 2013.

Therefore, Approved Hospitals will provide medical attendance and treatment facilities to Members and Ex-Members of Rajasthan Legislative Assembly as per provisions of above referred order dated 27.06.2015. Medical reimbursement to Members and Ex-Members shall be as per applicable provisions of Rules, 1964 and Rules, 2010 respectively.

This Order shall be deemed to come into force with immediate effect.
