ORDER

Sub: Amendments in Rajasthan Civil Services (Medical Attendance) Rules, 2013- Appendix- I: List of 'Approved Hospitals' and Appendix- IX, X, XI, XIII and XV

In exercise of the powers conferred under Rule 4 of the RCS (MA) Rules, 2013, following amendments, on the recommendation of the Health Benefit Empowered Committee (HBEC), are hereby made in Appendices to these Rules:

1. The State Government hereby includes the following hospital, as "Approved Hospital" as defined in Rule 3(5) of the aforesaid rules, in the Appendix-I of Rajasthan Civil Services (Medical Attendance) Rules, 2013 :-

(i) At Sr. No. 45 under A. Multi Specialty Hospitals:

45. Soni Hospital, Jaipur

(ii) At Sr. No. 3 under B. Cardiology and CT Surgery Super Specialty Hospitals:

3. Eternal Heart Care Centre and Research Institute, Jaipur

Note: (1) The rates of various treatments and discounts offered to State Government Employees in the above hospitals can be seen on the Finance Department website <http://finance.rajasthan.gov.in>

(2) The Hospital shall be bound not to charge, from State Government employees, more than the rates as may be fixed by the State Government from time to time for approved private hospitals for various treatments, investigations and implants.

(3) The Order will be effective upto 5 years from the date of issue.

2. In Appendix-IX, Table in Para (b) Stents is substituted as follows:


4. In Appendix-XI a 'Note' below table is inserted as follows:

Note: Medical reimbursement for the following treatments of Thalassemia Major in approved private hospital shall be limited to actual expenses or to the extent as given below, whichever is less:

S. No.	Item	Extent of reimbursement (Rs.)
1	Autologous Blood Transfusion	4,00,000
2	Allogenic Marrow Transplantation	7,00,000

5. In Appendix-XI and XIII extent of reimbursement for 'Doctor's Fees' is substituted as "Rs.400/- per day or actual whichever is less subject to the maximum limit of Rs.20,000/-."
6. In Appendix-XV a new entry as Item No. 4 is inserted as follows: "ICU and Ventilator Charges: Extent of reimbursement for ICU including ventilator charges shall be allowed @Rs.1200/- per day.
