**ORDER**

In compliance to State Cabinet Order No. 68/2018 dated 26.03.2018 and in exercise of the powers conferred by clause 8 of the Rajasthan Investment Promotion Scheme-2014, the State Government being of the opinion that it is expedient in the public interest so to do, hereby, makes the following amendments in this Department's order No. F.12(32)FD/Tax/2014-118 dated 01.02.2016 (hereinafter referred to as "the said order") regarding Customized Package in favour of M/s Mayur Uniquoters Ltd., with effect from 01.07.2017, namely:-

**AMENDMENTS**

1. **Amendment of Clause 2.-** The existing serial number 1 of clause 2 of the said order shall be substituted by the following, namely:-

1.	Subsidy	<p><b>A. Quantum of Subsidy:</b></p> <p>(i) <b>Investment Subsidy:</b> 55% of State Tax due and deposited by the enterprise;</p> <p>(ii) <b>Employment Generation Subsidy:</b> Up to 20% of State Tax due and deposited by the enterprise.</p> <p><b>B. Period of Subsidy:</b> The subsidy shall be available for a period of seven years from the date of issuance of entitlement certificate.</p>

2. **Amendment of Clause 5.-** The existing clause 5 of the said order shall be substituted by the following, namely:-

**“5. Applicability of the Provisions of the Rajasthan Goods and Services Tax Act, 2017, Rajasthan Value Added Tax Act, 2003, Central Sales Tax Act, 1956 and Rajasthan Investment Promotion Scheme -2014.-**

- (i) Provisions of the Rajasthan Goods and Services Tax Act, 2017 and rules made there under shall be applicable *mutatis mutandis*.
- (ii) Provisions of Rajasthan Value Added Tax Act, 2003 and rules made there under shall be applicable *mutatis mutandis*.
- (iii) Provisions of the Central Sales Tax Act, 1956 and rules made there under shall be applicable *mutatis mutandis*.



(iv) Subject to the provisions of the package, all the provisions of Rajasthan Investment Promotion Scheme -2014 shall apply *mutatis mutandis*.”


