ORDER

In compliance to State Cabinet Order No. 68/2018 dated 26.03.2018 and in exercise of the powers conferred by clause 8 of the Rajasthan Investment Promotion Scheme-2014, the State Government being of the opinion that it is expedient in the public interest so to do, hereby, makes the following amendments in this Department's order No. F.12(46)FD/Tax/2016-57 dated 18.11.2016 (hereinafter referred to as "the said order") regarding Customized Package in favour of M/s Om Prakash Stock Brokers Pvt. Ltd. (O.P. Dangayach Group), with effect from 01.07.2017, namely:-

AMENDMENTS

1. **Amendment of Clause 2.-** After the existing serial number 1 and before the existing serial number 2 of clause 2 of the said order, the following new serial number 1A shall be inserted, namely:-

1A.	Subsidy	<p>A. Quantum of subsidy :</p> <p>(i) Investment Subsidy:-50% of State Tax due and deposited by the enterprise for seven years;</p> <p>(ii) Employment Generation Subsidy: Up to 10% of State Tax due and deposited by the enterprise.</p> <p style="text-align: center;">Provided that the employment generation subsidy shall not be granted for the persons employed by the enterprise in relation to the services of entertainment.</p> <p>B. Period of Subsidy: The subsidy shall be available for a period of seven years from the date of issuance of entitlement certificate.</p>

2. **Amendment of Clause 5.-** The existing clause 5 of the said order shall be substituted by the following, namely:-

“5. Applicability of the Provisions of the Rajasthan Goods and Services Tax Act, 2017, Rajasthan Value Added Tax Act, 2003 and the Scheme.-

- (i) Provisions of the Rajasthan Goods and Services Tax Act, 2017 and rules made there under shall be applicable *mutatis mutandis*.
- (ii) Provisions of Rajasthan Value Added Tax Act, 2003 and rules made there under shall be applicable *mutatis mutandis*.
- (iii) Subject to the provisions of the package, all the provisions of the Scheme shall apply *mutatis mutandis*.”


