AMENDMENTS

- 1. Amendment of Clause 2.- In the said order, the existing Clause 2 shall be substituted by the following, namely:-
 - **"2. Benefits under the package:** The benefits mentioned in the table given below shall be allowed to the enterprise:-

S.No.	Nature of benefit	Benefits Under the package

1.	Subsidy	 A. Quantum of Subsidy: (i) Investment Subsidy: 40% of State tax due and deposited on the supply of goods manufactured in the State by the enterprise; (ii) Employment Generation Subsidy: Up to 20% of State tax due and deposited on the supply of goods manufactured in the State by the enterprise. Period of Subsidy: The subsidy shall be available for a period of seven years from the date of issuance of entitlement certificate.
2.	Exemptions	 (i) 50% Exemption from payment of Electricity Duty for 10 years on consumption of electrical energy in manufacturing of goods under notification number F.12(11)FD/Tax/2016-268 dated 30.03.2016 on the basis of Entitlement Certificate issued under the scheme. (ii) 100% Exemption from payment of Stamp duty on purchase or lease of land and construction on such land under notification number F.2(51)FD/Tax/2015-63 dated 23.07.2015 on the basis of Entitlement Certificate issued under the Scheme.
3.	Other Benefits	Other benefits, shall be available to the enterprise under the provisions of the scheme subject to fulfillment of eligibility conditions.

- **2. Amendment of Clause 4.-** In the clause 4 of the said order, the existing sub-clause (ii) shall be deleted.
- **3. Amendment of Clause 5.-** In the said order, the existing Clause 5 shall be substituted by the following, namely:-
 - **"5.** Applicability of the provisions of Rajasthan Goods and Services Tax Act, 2017 and the scheme.-
 - (i) Provisions of the Rajasthan Goods and Services Tax Act, 2017 and rules made there under shall be applicable *mutatis mutandis*
 - (ii) Subject to the provisions of the package, all the provisions of the Scheme shall apply *mutatis mutandis*."
