NOTIFICATION

In exercise of the powers conferred by section 28 of the Rajasthan Excise Act, 1950, (Act No. II of 1950), the State Government hereby makes the following amendments in this department's notification number F.4(62)FD/Ex/96 dated 31-03-1997, as amended from time to time, with immediate effect namely:-

AMENDMENTS

In the said notification, under the head 1. Excise Duty,-

(I) the existing serial number (i) and entries thereto shall be substituted by the following, namely:-

	Excise Duty
"(i) Indian Made Foreign Liquor/Spirit/Bottled in India (BII)/RTD having price including the amount of export fee and any other fee, excluding the amount of the Central Sales Tax (CST), payable per carton of Quarts, Pints, Nips or other size as declared by manufacturers and as accepted by the Rajasthan State Beverages Corporation Limited,-	
(a) upto Rs. 1000	Rs. 310 per LPL +80% of ex-distillery price
(b) above Rs. 1000 and upto Rs.2500	Rs. 370 per LPL +80% of ex-distillery price
(c) above Rs. 2500	Rs. 385 per LPL +80% of ex-distillery price"

(II) after the existing serial number (ii) and before the existing serial number (iii), the following new serial number (ii-a) shall be inserted, namely:-

	Excise Duty
"(ii-a) Indian Made Foreign Liquor (except Indian Made Rum) /Bottled in India (BII) for Defence Service, Ex-military Personnel, Border Security Force and Central Armed Police Forces Stationed in Rajasthan, obtained and supplied ,-	
(a) upto Rs. 1000	Rs. 310 per LPL +70% of Ad-valorem ex-distillery price
(b) above Rs. 1000 and upto Rs.2500	Rs. 370 per LPL +70% of Ad-valorem ex-distillery price
(c) above Rs. 2500	Rs. 385 per LPL +70% of Ad-valorem ex-distillery price"

(III) the existing serial number (vi) and entries thereto shall be substituted by the following, namely:-

(vi)	Type of liquor	Excise Duty (ad-valorem of Wholesale Issue Price)
	(i) 60 U.P. country liquor	120%
	(ii) 50 U.P. country liquor	156%
	(iii) 40 U.P. country liquor	170%
	(iv) 5 U.P. (Kesar Kasturi) country liquor	55%
	(v) Rajasthan Made Liquor (RML)	190%


