आदेश

विषय: सामान्य वित्तीय एवं लेखा नियमों के खण्ड—I के भाग—I में संशोधन।

राज्यपाल महोदय सामान्य वित्तीय एवं लेखा नियमों के खण्ड—I के भाग-I में निम्न संशोधन करने के आदेश एतदद्वारा प्रदान करते हैं:—

- 1. After the existing Rule 141, the following new sub-rule (1) and (2) shall be inserted as under:-
 - Rule 141 (1) Procedure for payment of interest subvention on house building advance to the employees of Rajasthan approved by Finance Department: After integration of amount of interest subvention with IFMS, as per account statement provided by respective loan disbursing Bank, a separate bill in the salary format (GA 36 P) shall be generated, along with the regular salary bill, for amount of interest subvention to the employees who are availing House Building Advance in the terms decided by the competent authority. This bill will be e-signed/D-signed by concerned DDO of office where officer is posted. The amount of interest subvention shall be deposited in the bank account of concerned employee as reported by respective loan disbursing bank in integration process.
 - (2) Procedure for payment of interest subvention for purchase of car under soft loan facility (Advance) to the employees of Rajasthan approved by Finance Department: After integration of amount of interest subvention with IFMS, as per account statement provided by respective loan disbursing Bank, a separate bill in the salary format (GA 36 Q) shall be generated, along with the regular salary bill, for amount of interest subvention to employees who are availing Advance under soft loan facility for purchase of car in the terms decided by the competent authority. This bill will be e-signed/D-signed by concerned DDO of office where officer is posted. The amount of interest subvention shall be deposited in the bank account of concerned employee as reported by respective loan disbursing bank in integration process.
- 2. The existing sub-rule (1) of Rule 150 of the said rules shall be substituted by the following, namely:-
 - Rule 150: Preparation of Bill: (1) Bills for pay, fixed allowances (permanent T.A., House Rent, Conveyance allowance, etc.) and leave salary shall be prepared separately for permanent and temporary establishments and All India Service Officers in System Generated New Form No. GA 36 for Regular Salary Bill, New Form Nos. GA 36 A Salary Arrear Bill, GA 36 B DA Arrear Bill, GA 36 C Surrender Bill, GA 36 D Surrender Arrear Bill, GA 36 E Bonus Bill, GA 36 F Leave Encashment Bill, GA 36 G Leave Encashment Arrear Bill, GA 36 H Salary Bill Reverse Deputation, GA

36 I - Salary Bill - Re-employment: Fix Pay, GA 36 J - Salary Bill - Re-employment: Pay Minus Pension, GA 36 K - Pay/Honorarium Bill: Government Employee, GA 36 L - Pay/Honorarium Bill: Nominated Members/Authority, GA 36 P - Interest Subvention on House Building Advance, GA 36 Q - Interest Subvention on Conveyance Advance except as provided otherwise, the name of every substantive and officiating or temporary Government servants shall be shown against each post, and against each temporary post shall be noted the sanction thereof alongwith the period for which the post is sanctioned.

The rate of pay claimed shall be noted and when pay is drawn for a portion of a month only, the number of days for which it is claimed shall be stated against the names of the Government servant in the body of the bill.
