**CIRCULAR**

The Government of Rajasthan has decided to strengthen and streamline the public procurement system by developing the **Single Holistic Procurement Portal (SHPP)** for the State of Rajasthan.

Second Phase of Single Holistic Procurement Portal (SHPP) for Procurement Under Open Competitive Bidding (OCB) is now on Trial for User Acceptance Testing (UAT) from 01-04-2026 for the following 12 departments.

3. Director, Department of Science and Technology (DST)
4. Director, Department of Tourism
5. Principal, SMS Medical College, Jaipur

8. Commissioner, Department of Information Technology & Communication (DoIT&C).
9. Commissioner, Department of Agriculture
10. Commissioner, Department of Industries
11. Director, Department of Medical, Health & Family Welfare
12. Commissioner, Excise Department


All above Heads of Departments (HODs) are requested to form departmental user groups, for the purpose of testing of already completed tenders on SHPP test site and issue necessary instructions to all concerned officials - including officers-in-charge, accounts officials, store-in-charge officials, and all other officials engaged in procurement and stores management. It is mandatory to carry out testing of procurement activities completed in the last six months, through the SHPP test portal for User Acceptance Testing (UAT) purposes.

This User Acceptance Testing (UAT) is important for integrating the feedback of user departments in the final version of OCB module in SHPP.


