Circular

The Government of Rajasthan is committed to enhance transparency, efficiency and ease of doing business in the public procurement process. To achieve this objective, the Finance Department has developed the Single Holistic Procurement Portal (SHPP). The first phase of SHPP was implemented vide Circular No. F.3(2)FD/SPFC/SPPP/SHPP/2024 dated 16.03.2026.

It has now been decided to undertake Phase-II of SHPP **on a pilot basis implementation** with effect from 01 June, 2026 in the following Departments/Offices:-

1. Commissioner, Department of Industries
2. Commissioner, Department of Agriculture
3. Director, Women and Child Development Department (WCD)
4. Director, Department of Science and Technology (DST)
5. Director, Department of Tourism
6. Principal, SMS Medical College, Jaipur
7. Joint Secretary, Department of Personnel (DoP)
8. Director, Department of Treasury and Accounts (DTA)
9. Director, Local Fund Audit Department (LFAD)
10. Public Works department, Jaipur (Rural) Circle

This phase will cover the following modules: -

1. Open Competitive Bidding
2. Rate Contracts
3. Reverse Auction
4. Appeal Management System
5. Procurement Plan Management
6. E- Sanction
7. Single Source Procurement


All these departments are hereby advised to undertake procurement through SHPP for the above-mentioned procurement methods with effect from 1 June, 2026.

It shall be the duty and responsibility of all **Heads of Departments (HODs)** to issue necessary instructions to all concerned officials - including **officers-in-charge, accounts officials, store officers and all other officials, associated with procurement and stores management** to mandatorily carry out procurement activities through SHPP.
