NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Civil Services (Contributory Pension) Rules, 2005, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan Civil Services (Contributory Pension) (Amendment) Rules, 2021.

(2) They shall come into force w.e.f. 01-09-2021.

2. Amendment in rule 4.- The existing clause (i) and (ii) of rule 4 of the Rajasthan Civil Services (Contributory Pension) Rules, 2005, hereinafter referred to as the said rules, substituted as under:-

"(i) it would be mandatory for new recruits to become member of the new contributory pension scheme and the monthly contributions to their pension account shall be @10 percent of the Basic Pay and Dearness Allowance paid from the salary of the employee and a matching amount shall be contributed by the State Government. This matching contribution from the State Government shall be charged to the budget head 2071.

(ii) The Contribution would be transferred into respective pension account of Central Recordkeeping Agency (CRA) by Treasury system i.e. Integrated Financial Management System (IFMS)."

3. Substitution of Rule 8.- The existing rule 8 of the said rules shall be substituted by the following, namely :-

"8. Recovery of the Deposit-

The Heads of Office shall prepare pay bill in respect of the Government servants joining government service on or after 1-1-2004 and make deduction at the time of salary bill in system generated schedules in prescribed forms (Annexure IV) with auto checking process. The system generated schedules in prescribed form (Annexure V) will be processed for matching contribution."

4. Substitution of Rule 9.- The existing rule 9 of the said rules shall be substituted by the following, namely :-

"9. Passing of bills and preparation of data base -

(i) On receipt of the salary bills through automation mode, the Treasury Officer will exercise usual checks and pass the bills for payment.

(ii) Immediately after the payment of salary, two auto bills will be generated through data of schedules for employee contribution and Government contribution. These Contributions shall be transferred into respective pension account of CRA by Treasury system i.e. IFMS. These Contributions shall be transferred into respective pension account of CRA through auto generated schedules i.e. Annexure V and VI. "

5. Substitution of Rule 10.- The existing rule 10 of the said rules shall be substituted by the following, namely :-

"10. Auto bill generation

(i) Auto bills will be generated for budget head 8011 and 2071 through data of schedules for employee contribution and Government contribution. These Contributions shall be transferred into respective pension account of CRA by Treasury system i.e. IFMS through auto generated schedules i.e. Annexure V and VI.

(ii) Data of employees related to NPS contribution will be provided to CRA through integration directly from IFMS to CRA and IFMS to State Insurance and Provident Fund Department."

6. Amendment in Annexure V.- In the existing Annexure V, the words "Signature & Name of Head of office with office seal" shall be substituted by the words "Signature & Name of Treasury Officer "

7. Addition of new Annexure VI.- After the existing Annexure V of the said rules, the following new Annexure VI shall be added, namely:-




