Notification

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan is pleased to make the following rules further to amend the Rajasthan Civil Services (Revised Pay) Rules, 2017, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan Civil Services (Revised Pay) (first amendment) Rules, 2022.

(2) They shall come into force with effect from 01.01.2016.

2. Amendment of Schedule-II.- the existing entries at S.No. 2 and 3 in Section - 'A' of Schedule-II appended to the Rajasthan Civil Services (Revised Pay) Rules, 2017, appearing under sub-heading '(ii) Rajasthan Police Subordinate Service Wireless', under Sub-heading '(C) RAJASTHAN POLICE SERVICE WIRELESS ORGANISATION', and under heading 'POLICE DEPARTMENT' shall be substituted by the following, namely,-


