Notification

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan is pleased to make the following rules further to amend the Rajasthan Civil Services (Revised Pay) Rules, 2017, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan Civil Services (Revised Pay) (First Amendment) Rules, 2022.

(2) They shall come into force with effect from 01.01.2016.

2. Amendment of Rule 14.- under the existing Sub-rule (2) of rule 14 of Rajasthan Civil Services (Revised Pay) Rules, 2017, an exception shall be inserted namely,-

Exception- (i) An employee whose pay has been fixed in Pay Level L-5 or L-6 as initial Pay Level of the post or as ACP, in such cases the next ACP, if admissible, shall be in the Pay Level L-8.


(ii) An employee whose pay has been fixed in Pay Level L-8 as initial Pay Level of the post or as ACP, in such cases the next ACP, if admissible, shall be in the Pay Level L-10.

(iii) An employee whose pay has been fixed in Pay Level L-13 as initial Pay Level of the post or as ACP, in such cases the next ACP, if admissible, shall be in the Pay Level L-15.

3. Amendment of Rule 15.- under the existing Sub-rule (2) of rule 15 of Rajasthan Civil Services (Revised Pay) Rules, 2017, an exception shall be inserted namely,-

Exception- Employees whose pay has been fixed in Pay Level L-13 as initial Pay Level of the post or as ACP, in such cases the next ACP, if admissible, shall be in the Pay Level L-15.


