ORDER

Subject :- House Rent Allowance Rules, 1989

In exercise of the powers conferred under Rule 42 of the Rajasthan Service Rules, the Governor is hereby pleased to make the following amendment in the House Rent Allowance Rules, 1989 :-

In the said rules -

- (a) The existing "Rs 500" in Sub-Rule (2) of Rule 2 shall be substituted by "Rs 9000/-".
- (b) The existing Sub-rule (4) of Rule 4 alongwith clarification shall be substituted as under :

"The allowance shall be granted to a Government servant from the date of occupation of the rented/owned accommodation, on submitting a certificate in the form given in Annexure "A" within the same financial year, however, if a Government servant is transferred in the month of March then he will be allowed to submit Annexure 'A' within a month. HRA claims shall not be considered for previous postings.

Provided that in matters of successful completion of probation trainee period or drawal of pay in regular pay scale in case of Probationer Trainees, House Rent Allowance shall be admissible only after drawal of pay in regular pay scale."

Note : An IT system shall be developed to send one time SMS reminder to employees about HRA availment option after each transfer.

- (c) Under Rule 8(1) the word "Annexure 'B' " shall be substituted by word "Annexure 'A' ".
- (d) Rule 9 shall be deleted.
- (e) Annexure "A" shall be deleted
- (f) Annexure "B" shall be named as Annexure "A".

This order shall come into force with immediate effect.
