NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules further to amend the Rajasthan Service Rules, 1951, namely.-

- 1. Short title and commencement. -(1) These rules may be called the Rajasthan Service (Second Amendment) Rules, 2024.
- (2) They shall come into force with immediate effect.
- **2.** Insertion of Rule 26 D.- In the aforesaid rules after the Rule 26C the following new Rule 26D shall be inserted, namely -
- "26D. Fixation of pay in the case of appointment / promotion on urgent temporary basis.- Fixation of pay in the case of appointment / promotion on urgent temporary basis shall be made as under:-
- (a) Pay last drawn plus allowances viz. DA, HRA and CCA if admissible on the last post.

or

(b) Fixed remuneration equal to the amount of first cell of Pay Level of the Pay Matrix of the post under the Rajasthan Civil Services (Revised Pay) Rules, 2017 without any allowance like DA, HRA and CCA, whichever is more.

Amount of first cell of Pay Level of the Pay Matrix of the posts under the Rajasthan Civil Services (Revised Pay) Rules, 2017 are as under:-
