With reference to the above cited subject an order of even number dated 12.09.2024 was issued, regarding grant of notional increment to the employees who had completed incremental period of service and retired on 30<sup>th</sup> June, 2006, and following 30<sup>th</sup> June, thereafter whose increment becomes due on the next day following upon their retirement, and on completing one year of satisfactory service.
