MEMORANDUM

Sub: Amendment in the Rajasthan Pensioners' Medical Concession Scheme, 2021

The Governor is hereby pleased to make the following amendments in the Rajasthan Pensioners' Medical Concession Scheme, 2021, namely:-

Amendment in para 4.- In para 4 of the said Scheme, after the proviso under sub-para (1) and before the Note, the following is hereby inserted :

"Provided further that Vitamins, Minerals and Anti-oxidant shall be made available upto the limit of Rs 3000/- per annum for the pensioners who have attained the age of 75 years or above in the case of following treatments/diseases :

(i) Cancer, (ii) Chronic Liver Disease, (iii) Kidney Failure, (iv) Major Organ Transplant (i.e. Kidney, Lungs, Liver and Bone Marrow Transplant) and (v) Strokes resulting in permanent symptom / Parkinsons disease

The payment of Vitamins, Minerals and Anti-oxidant as prescribed by authorized medical attendant shall be made to pharma stores / e-pharma stores on RGHS rates."

This amendment shall come into force with immediate effect.
