**ORDER**

Sub:- Allowing officers of All India Services, State Services and Judicial Officers to retain Laptop, Printer, Note Book, IPad and Tablet given to them in official capacity after depositing depreciated value.

In continuation to earlier orders of even number dated 07.10.2023 and 04.09.2024, it has been decided that the officers of All India service, State Services and Judicial Officers may be allowed to retain old Laptop, Printer, Note Book, IPad and Tablet given to them in official capacity after depositing depreciated value subject to following revised conditions:

- a) Post completion of four years of date of purchase, the officer whom such device is issued, may be allowed to retain it. The concerned department shall obtain a declaration from concerned officer that the official data (if any) in the device is completely wiped out (data sanitized).
- b) Generally, no new device should be issued to an officer who has already been allotted a device up to four years from date of issuance of purchase of the first device except in case of damaged device or any other reason based on functional requirement.
- c) In the cases, an officer has been issued a device and he/she retires on superannuation or takes voluntary retirement within 4 years of purchase of such device, the officer concerned will have the option to retain the device by paying the amount equal to depreciated value of the device on such date of leaving the service as per details given in para 2 of the order of even number dated 07.10.2023.



d) Other terms and conditions would remain same as mentioned in the order of even number dated 07.10.2023 and 04.09.2024.
