**ORDER**

**Sub: Regarding Soft Loan Facility (Advance) for purchase of Car by Officers of Rajasthan Judicial Service.**

**Ref: Law and Legal Affairs Department's order No.F.26(55)Nyay/2015 Part IV dated 28-3-2024.**

With reference to the subject cited above, in the referred order at point No. 1, Soft Car loans facilities was allowed as under :

*"Soft Car loans facilities to the extent of Rs ten lakhs to Judicial Officer is allowed on simple interest rates @ 4% per annum, if the amount of the car loan is arranged through nationalized banks, then difference amount of interest will be borne by the State Government"*

To streamline the procedure for Soft Loan Facility (Advance) for purchase of Car by Officers of Rajasthan Judicial Service and the procedure for interest subvention the following guidelines are hereby issued :

**Guidelines for Soft Loan Facility (Advance) for purchase of Car by Officers of Rajasthan Judicial Service**

1. Car Loan shall be arranged through Nationalized Bank for which MOU shall be executed by Finance Department.
2. Judicial Officer shall repay the Loan/Advance amount (along with interest accrued) in Equated Monthly Instalment (EMI) as per MOU.
3. The rate of interest for interest subvention on the Loan/Advance amount shall be at a fixed rate of 4% per annum and computation of interest shall be on the amount due after adjustment of the deposited amount. For interest subvention the maximum car loan limit shall be Rs 10.00 lacs.
4. For the offices where salary is disbursed through IFMS, following procedure shall be applicable :
  - (i) The Nationalized Bank shall be integrated with IFMS for the purpose of providing account statement for interest subvention of concerned judicial officers.

(ii) Nationalised Banks shall provide account statement for interest subvention of concerned judicial officers upto 20th of every month to IFMS, so that amount of interest subvention shall be integrated with IFMS before disbursement of salary.

(iii) After integration of amount of interest subvention with IFMS as per account statement provided by Nationalized Banks, a separate bill in the salary bill format shall be processed for amount of interest subvention of judicial officers who are availing soft loan facility, as per procedure.

(iv) After passing of bill the amount of interest subvention shall be deposited in the bank account of concerned judicial officer.

5. For the offices where salary is not disbursed through IFMS, following procedure shall be applicable :

(i) Nationalised Banks shall provide account statement for interest subvention of judicial officers upto 20th of every month, to the concerned office where judicial officer is posted.


(ii) After account statement for interest subvention a separate bill in the salary bill format shall be processed for amount of interest subvention of judicial officers who are availing soft loan facility, by the concerned office as per procedure.

(iii) After passing of bill the amount of interest subvention shall be deposited in the bank account of concerned judicial officer.

6. Nationalized banks shall also provide interest subvention certificate and/or account statement to the borrower as per demand.

7. Interest subvention amount shall be paid from object head 57 of the concerned salary head.

8. No interest subvention shall be allowed for default and/or delay on part of judicial officer.
