ORDER

Sub: Revised Guidelines for supply and delivery of drugs and medicines under RGHS through (i) Pharma Stores and (ii) E-Pharma Stores.

Ref: This Department's orders of even number dated 09-06-2024 and 05-09-2024.

State Government vide orders of even number dated 09-06-2024 and 05-09-2024 had issued guidelines related to supply and delivery of drugs and medicines under RGHS.

The matter was re-considered and Sr. No. 4 of point No. 4.1 of Annexure - A of the order dated 5-9-2024, is hereby substituted as under :

4.1 Eligibility of empanelment of Pharma store:

4	<p>The pharma stores shop should be registered in respective city of Rajasthan under Shops and Establishment Act/ Indian Partnership Act 1932 / Companies Act 1956/Limited Liability Act 2008 and should be in existence for at least last one financial year.</p> <p>Provided that the condition of existence for at least last one financial year shall not be applicable in following cases:</p> <p>(i) Where pharma store / e-pharma store under RGHS is already situated in the authorized premises of empanelled hospital and a new branch is started in the same premises of empanelled hospital.</p> <p>(ii) When a chain of pharma stores / e-pharma stores approved under RGHS starts a new branch of pharma stores / e-pharma stores.</p> <p>(iii) When chain of hospitals starts a new branch of hospital and this hospital is empanelled under RGHS and any pharma store situated in its premises</p> <p>(iv) When a new pharma store is opened in the premises of the any established empanelled hospital of chain of hospitals.</p>	<p>Copy of:</p> <p>(a) Registration Certificate issued by competent authority under Shops and Establishment Act/ Indian Partnership Act 1932 / Companies Act 1956 with name and complete postal address of the shop located in the respective place in Rajasthan.</p> <p>(b) the relevant ownership deeds along with full details of ownership and control of each member thereof. e.g. Proprietorship/ Partnership Deed/Memorandum or Articles of Association for company.</p>
