#### ORDER

Sub: Constitution of Committee as per order dated 5.3.2025 of Hon'ble High court, Rajasthan (Jaipur Bench) passed in DB Civil Writ No. 17484/2024 Rajasthan Sevanivritt Police Kalyan Sansthan v/s State of Rajasthan and Ors. and connected matters for period of restoration of commutation of pension.

Hon'ble High court, Rajasthan (Jaipur Bench) in the DB Civil Writ No. 17484/2024 Rajasthan Sevanivritt Police Kalyan Sansthan v/s State of Rajasthan and Ors. and connected matters vide order dated 5.3.2025 has issued the following directions on the issue of restoration of commutation of pension:

- 5. Learned Advocate General would submit that if any representations are made, the State would examine the same.
- 6. Taking into consideration the nature of exercise required to be undertaken which involves financial implications also, the State may constitute a Committee of Experts which shall examine the grievance of the pensioners-petitioners. The Committee may submit its recommendations to the State and it will be open for the State to take such decision as it considers appropriate in the matters.
- 7. Taking into consideration that grievance has been raised by those who are retired employees, the Committee shall endeavour to submit its report within a period of six months.
- 8. The writ petitions are disposed off accordingly with liberty to file fresh petition in case grievance is not redressed.

In view of the above direction of Hon'ble High Court, following Committee is hereby constituted to look into the period of restoration of commutation of pension in terms of Rajasthan Civil Services (Commutation of Pension) Rules, 1996:

- Principal Secretary, Finance (Budget) Chairman
- Representative of Principal Secretary Law not below the rank of Joint Secretary, Law - Member
- Technical Member as representative of Secretary, Information and Technology -Member
- 4. Joint Secretary, Finance (Pension) Member
- 5. Joint Secretary, Finance (Rules-II) Member
- 6. Joint Secretary, Finance (Ways and Means) Member
- 7. Joint Secretary, Statistics Department Member
- 8. Director, Pension and Pensioners Welfare Department Member Secretary

Committee may also invite experts from LIC and Banking sector as special invitee.

Terms of reference (TOR) shall be as under:

- To study and analyze various parameters w.r.t. State of Rajasthan i.e. (i) Commutation factor, (ii) the rate of interest, (iii) the life expectancy, (iv) the mortality rate, (v) death rates, (vi) risk factor.
- To study period of restoration in Central Government and various State Governments.
- To study various judgments passed by Hon'ble Supreme Court and various Courts w.r.t. period of restoration of commutation.
- 4. To study and analyze rate of interest charged by various financial institutions and banks on borrowing loans.
- Other relevant issues.

The above referred Committee shall submit its report latest by 31-05-2025
