CIRCULAR

**Sub: Regarding fixation of pay of employees of State PSUs/
Autonomous Bodies/ Local Bodies/ Panchayati Raj Institutions etc.
appointed in Government service through direct recruitment.**

Attention is invited to the provisions contained in the Finance Department Circular of even number dated 01.09.2025 wherein it has been clearly specified that the employees of State PSUs/Autonomous Bodies/Local Bodies/Panchayati Raj Institutions etc. are not Government servants. Therefore, if such employees are appointed in Government service through direct recruitment, the last pay drawn by them in their previous post is not admissible for protection under Rules 24 and 26 of Rajasthan Service Rules, 1951.

Despite these clear provisions, references are still being made to the Finance Department seeking protection of the last pay drawn in the State PSUs/Autonomous Bodies/Local Bodies/Panchayati Raj Institutions etc., on the ground that in certain cases Administrative Departments have implemented the judgment of the High Court and protected the last pay drawn without following the due procedure prescribed by the State Government for implementation of High Court judgments. As per the prescribed procedure, such judgments are required to be first examined by the Pre-Litigation Committee and thereafter approval of the Finance Department must be obtained either for filing an appeal or implementation of the judgment.

It is, therefore, again enjoined upon all Administrative Department's/ Heads of Department's to strictly follow the procedure prescribed by the State Government for implementing or for filing appeal against the judgment of the High Court/Appellate Tribunal.



In view of the above provisions, it shall be ensured by all Administrative Departments/Head of the Departments that on appointment to Government service through direct recruitment, employees of State PSUs/ Autonomous Bodies/ Local Bodies/ Panchayati Raj Institutions etc. shall not be granted protection of the last pay drawn by them in the State PSUs/ Autonomous Bodies/Local Bodies/Panchayati Raj Institutions etc. under Rules 24 and 26 of Rajasthan Service Rules, 1951.
