In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan is pleased to make the following rules further to amend the Rajasthan Civil Services (Revised Pay) Rules, 2008, namely:-

**1. Short title, extent and commencement.-** (1) These rules may be called the Rajasthan Civil Services (Revised Pay) (Thirteenth Amendment) Rules 2015.

(2) They shall be deemed to have come into force with effect from 01.07.2013.

**2. Amendment of Schedule-I.-** In Section-B of Schedule-I appended to the Rajasthan Civil Services (Revised Pay) Rules, 2008,-


