In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor is pleased to make the following rules to amend further the Rajasthan Civil Service (Revised Pay) Rules, 2017, namely:-

1. These rules may be called the Rajasthan Civil Services (Revised Pay) (Third Amendment) Rules, 2017.
2. These rules shall be come into force with effect from 01-01-2018.
3. In the Rajasthan Civil Services (Revised Pay) Rules, 2017, in Schedule V-Advance increments - below the existing S.No. 2, following new entry at S.No. 3 shall be inserted, namely :-

S. No.	Name of the Post	Level	Advance Increments
1	2	3	4
3.	Rajasthan Medical & Health Service (General Branch); Senior Medical Officer	L-16	For Post Graduate Degree or equivalent Diploma in any branch of Medicine or Surgery;- (1) Senior Medical Officers who are possessing/acquiring P.G. Degree while in service shall be allowed three advance increments equal to difference in the pay drawn and next cell in the Level of the Pay Matrix of the post and the sum of amount of three increments shall be added in the pay drawn. Thereafter the pay shall be fixed at an equal stage and if there is no equal stage than

			<p>at immediate next below cell.</p> <p>(2) Senior Medical Officers who are possessing/acquiring Diploma equivalent to P.G. Degree while in service shall be allowed two advance increments equal to difference in the pay drawn and next cell in the Level of Pay Matrix of the post and the sum of amount of two increments shall be added in the pay drawn. Thereafter the pay shall be fixed at equal stage and if there is no equal stage than at immediate next below cell.</p> <p>(3) These provisions shall not be applicable to those who have already availed benefit of higher initial pay/advance increments as Medical Officer.</p>
