NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan is pleased to make the following rules further to amend the Rajasthan Civil Services (Medical Attendance) Rules, 2013, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan Civil Services (Medical Attendance) (Amendment) Rules, 2021.
(2) They shall come into force with immediate effect.

2. Amendment of rule 9.- The existing sub-rule (2) of rule 9 of the Rajasthan Civil Services (Medical Attendance) Rules, 2013, hereinafter referred to as the said rules, shall be substituted by the following, namely:-

"(2) A Government servant, including his/her family members, who is on duty to Delhi or posted at Delhi shall be entitled to medical attendance and treatment as an indoor or outdoor patient in Approved Hospitals listed in Appendix - XII on the scale and as per conditions specified in rule 7 of these rules, as if he / she has been on duty in Rajasthan."

3. Substitution of Appendix-XII.- The existing Appendix - XII of the said rules shall be substituted by the following, namely :-
