**ORDER**

**Sub: Amendment in Rajasthan Civil Services (Medical Attendance) Rules, 2013 in Appendix- I: List of 'Approved Hospitals'**

In exercise of the powers conferred under Rule 4 of the of Rajasthan Civil Services (Medical Attendance) Rules, 2013 and as per the decision of the Health Benefit Empowered Committee (HBEC), the State Government hereby includes the following hospitals in Appendix -I, as "Approved Hospital" as defined in Rule 3(5) of aforesaid rules:-

5. Gurukripa Hospitals, Jyoti Nagar, Sikar (Multi-specialty category)

7. Jaipur Doorbeen Hospital, New Sanganer Road, Jaipur (E&T specialty category)
8. Fortis Escorts Hospital, Malviya Nagar, Jaipur (Multi-specialty category) - valid upto 3-3-2025
9. Royal Eye Care and Research Centre, Adarsh Nagar, Jaipur (Ophthalmology-specialty category) - valid upto 12-10-2022
10. Rukmani Birla Hospital, Gopalpura By-pass Road, Jaipur (Multi-specialty category) - valid upto 7-1-2023
11. Amar Medical and Research Centre, Mansarovar, Jaipur (Multi-specialty category) - valid upto 29-7-2023

Note:

- (1) For Sr. No. 1 to 7, the Order will be effective upto 5 years from the date of issue.
- (2) For Sr. No. 8 to 11, the Order will be effective for 5 years upto the period of issue of original orders as mentioned above.
- (2) The hospital shall be bound not to charge, from the State Government employees, more than the rates as may be fixed by the State Government from time to time for approved private hospitals for various treatments, investigations and implants.
