NOTIFICATION

**Sub. :- Rajasthan Civil Services (Revised Pay) Rules,
2008.**

In exercise of the power
s conferred by the proviso to Article 309 of the Constitution of
India, the Governor of Rajasthan is pleased to make the following
rules to amend further the Rajasthan Civil Services (Revised Pay)
Rules, 2008, namely :-

1. These rules may be called the Rajasthan Civil Services
(Revised Pay) (Thirteen Amendment) Rules, 2013.

2. They shall come into force with effect from 01.07.2013.

3. In the Rajasthan Civil Services (Revised Pay) Rules,
2008 - In Schedule -VI -

(i) after the existing item (iii) appearing in column 4 against
S.No.1, the following new item (iv) shall be inserted namely :-

"(iv) The Medical Officer/Senior Demonstrator who have
acquired Post Graduate Degree or equivalent Diploma
in any branch of Medicine or Surgery during the period
from 06.05.2002 to 30.06.2013 and also promoted on
higher post shall be allowed two advance increments
on notional basis from the date they acquired Post
Graduate Degree or equivalent Diploma and their pay
shall be fixed on the higher post on notional basis, on
the basis of notional pay as Medical Officer / Senior
Demonstrator as a result of grant of two advance
increments and actual payment shall be made from
01.07.2013.

(ii) after the existing S.No.1, the following new entry at S.No.2, shall be inserted, namely :-

Ayurved / Unani/ Homeopathy Departments (i) Ayurved/ Unani / Homeopathic Chikitsak (ii) Demonstrator	5400/- 5400/-	<p>For Post Graduate Degree in relevant subject.</p> <p>(i) Fresh recruits shall be allowed three non compounded advance increments.</p> <p>(ii) Existing persons who have acquired these qualifications during the period from 01.05.1998 to 30.06.2013 / acquires these qualifications while in service on or after 01.07.2013 shall be allowed three non compounded advance increments.</p> <p>(iii) Provisions of item (ii) above shall not be applicable to those who have already availed benefit of higher initial pay/ advance increments in accordance with the provisions in force prior to 01.05.1998.</p> <p>(iv) The Ayurved/ Unani / Homeopathic Chikitsak and Demonstrator who have acquired Post Graduate Degree in relevant subject during the period from 01.05.1998 to 30.06.2013 and also promoted on higher post shall be allowed two advance increments on notional basis from the date they acquired Post Graduate Degree in relevant subject, their pay shall be fixed on the higher post on notional basis, on the basis of notional pay as Ayurved/ Unani / Homeopathic Chikitsak and Demonstrator as a result of grant of two advance increments and actual payment shall be made from 01.07.2013.</p> <p>(vi) The Ayurved/ Unani / Homeopathic Chikitsak and Demonstrator who have been allowed higher initial pay/ advance increments before 01.05.1998 shall also be allowed two advance increments on notional basis w.e.f. 01.05.1998 to 30.06.2013. The actual payment shall be allowed from 01.07.2013 on the basis of notional pay.</p>
