ORDER

Sub: Rajasthan Civil Services (Medical Attendance) Rules, 2013, Appendix- I: List of 'Approved Hospitals'

In exercise of the powers conferred under rule 4 of the RCS (MA) Rules, 2013 and as per the decision of the Health Benefit Empowered Committee (HBEC), the State Government hereby:-

1. Includes the following hospitals as "Approved Hospital" as defined in rule 3(5) of Rajasthan Civil Services (Medical Attendance) Rules, 2013, in the Appendix-I :-
 - (1) Bindal Hospital, Sikar in Multispecialty category.
 - (2) Kshetrapal Eye Hopsital and Lasik Laser Centre, Ajmer in Ophthalmology category.
2. Extends the empanelment of Porwal Hospital Pvt. Ltd., Bhilwara in Multispecialty category.

Note:

- (1) The hospital shall be bound not to charge, from the State Government employees, more than the rates as may be fixed by the State Government from time to time for approved private hospitals for various treatments, investigations and implants.
- (2) The Order will be effective upto 5 years from the date of issue.
