MEMORANDUM

Subject :- Permission for exercise of option / re-option under the Rajasthan Civil Service (Revised Pay) Rules, 2008.

The Rajasthan Civil Services (Revised Pay) Rules, 2008 have been made effective from 01.01.2006 instead of 01.09.2006 vide FD Notification No. F. 14(1)FD/Rules/2013 - II dated 06.04.2013.

Owing to these amendments the right of the option has accrued to the Government servants under Rule 11(4) of the aforesaid rules. Under Rule 11(4) of these rules, the Government servants can exercise option / re-option within a period of three months of the Notification dated 06.04.2013.

Moreover, in these rules certain amendments have been made vide Notification No. F. 14(1)FD/Rules/2013 - I dated 06.04.2013, F.14(1)FD/Rules/2013 - I dated 28.06.2013 and F.14(1)FD/Rules/2013 - II dated 28.06.2013 effective from 01.07.2013.

It has been brought to the notice of the Government that some Government servants could not exercise option / re-option within the prescribed time limit under Rule 11(4) and in terms of provisions contained in sub-rule (3)(i) of Rule 11, they shall be deemed to have exercised option for revised pay scales 2008 with effect from 01.01.2006, which might result in a disadvantageous position. Likewise, some of the Government servants have exercised option in incorrectly without understanding the proper implications of the rules governing fixation of pay and exercise of such incorrect option has put them to financial loss.

The matter has been considered sympathetically and it has been decided that all Government servants may be permitted to exercise option / re-option under Rule 11(4) of the aforesaid rules upto 30th September, 2013.
