**Subject : Rajasthan Civil Services (Revised Pay) Rules, 2008.**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan is pleased to make the following rules to amend further the Rajasthan Civil Services (Revised Pay) Rules, 2008, namely :-

1. These rules may be called the Rajasthan Civil Services (Revised Pay) (Third Amendment) Rules, 2011.
2. They shall be deemed to have come into force with effect from 11.07.2011.
3. In the Rajasthan Civil Services (Revised Pay) Rules, 2008 - in Medical and Health Department -in Section 'B' of Schedule - I - the existing entries at S.No. 10 and 11 appearing under sub - heading " (i) Rajasthan Medical and Health Service", shall be deleted and the existing entry at S.No. 12 shall be substituted by the following, namely :-

Principal Chief Medical Officer / Principal Specialist / Additional Director (The existing post of Senior Specialist (SG)/ Joint Director has been re-designated as above)	13500-17500 14300-18300	PB-4	37400-67000	22	8700	(1) The Medical Officers on their third promotion shall be posted in Districts / Directorate and shall be designated as Principal Chief Medical Officer  (2) The Principal Specialist shall be posted in Hospitals and on their posting in Directorate shall be designated as Additional Director.

**Note:** Initial fixation of pay of the incumbents drawing pay in existing grade pay 8200/- shall be made in the revised RPB 37400-67000 at an equal stage with reference to the pay in the existing RPB 15600-39100. In cases where the pay in existing RPB 15600-39100 is less than the minimum of the revised RPB 37400-67000, then the pay shall be fixed at the minimum of the revised running pay band of 37400-67000 i.e. Rs. 37400/- In addition to the pay fixed as above grade pay of Rs. 8700/- shall be admissible. No other benefit shall be admissible.
