CLARIFICATION

Sub: Rajasthan Civil Services (Medical Attendance) Rules, 2013, Extent of reimbursement of cost of implants

Para (c) of Appendix-IX to the RCS (MA) Rules, 2013 provides extent of reimbursement of cost of implants for which rates have not been specified as follows:

| | | |
|----|-----------------|---|
| 1. | First Rs 5000/- | Rs 5,000/- (100%) |
| 2. | Next Rs 5000/- | Rs 4,000/- (80%) |
| 3. | Rest Amount | 50% of the remaining amount subject to maximum of Rs 35,000/- |

It is clarified that above mentioned calculation table is for single unit of implant. If more than one unit of same implant is used in treatment at a time, reimbursable amount is to be calculated separately for both units.

For example, if hearing aid is recommended for both the ears and cost per unit of hearing aid is Rs.25000/- , then total reimbursable amount will be as follows:

| 2. | Next Rs 5000/- | Rs 4,000/- (80%) |
| 3. | Rest Amount (25000- 10000=15000) | 50% of the remaining amount subject to maximum of Rs 35,000/-, i.e., Rs.7500/- |
| 4. | Total reimbursable amount per unit of hearing aid | Rs.16,500/- |
| 5. | Total reimbursable amount for hearing aid for both ears | Rs.16,500x2=Rs.33,000/- |
