
1. In Appendix –XI a 'Note' below table is inserted as follows:-

Note:- Reimbursement for specific treatments (included in Appendix –X (a)) taken in private hospitals in emergent circumstances shall be limited to the actual expenses or to the extent given in Appendix – X (a) to these Rules, whichever is less.
