ORDER

Sub: Rajasthan Civil Services (Medical Attendance) Rules, 2013, Appendix- I: List of 'Approved Hospitals'

In exercise of the powers conferred under Rule 4 of the RCS (MA) Rules, 2013 and as per the decision of the Health Benefit Empowered Committee (HBEC), the State Government hereby:-

1. Extends the empanelment of following hospitals as "Approved Hospital" as defined in Rule 3(5) of the Rajasthan Civil Services (Medical Attendance) Rules, 2013:

- (2) The hospital shall be bound not to charge, from the State Government employees, more than the rates as may be fixed by the State Government from time to time for approved private hospitals for various treatments, investigations and implants.
- (3) The Order will be effective upto 5 years from the date of issue.
