Sub.: Regarding rounding off the amount of annual increment to next multiple of 10 under Rajasthan Civil Services (Revised Pay) Rules, 2008.

Sir,

I am directed to refer on the subject cited above and to say that a case of incorrectly rounding off the amount of increment in favour of Shri Babu Lal Sharma, Office Assistant, Office of the Superintending Engineer, Construction and Maintenance Circle, IGNP, Phalodi, has come to the notice of Finance Department, wherein increment at the rate of 3% of the sum of his pay in the Running Pay Band and Grade Pay - Rs.20340/-, which comes to Rs.610.20 has been rounded off to Rs.620/- instead of Rs.610/- w.e.f. 01.07.2007 by the Superintending Engineer, Construction and Maintenance Circle, IGNP, Phalodi (Jodhpur).

As per provisions contained in Rule 13 *ibid*, the rate of increment in the running pay band is 3% of the sum of the pay in the running pay band and grade pay applicable, which is to be rounded off to the next multiple of 10.

Accordingly, in the aforesaid case of Shri Babu Lal Sharma, Office Assistant, increment at the rate of 3% of the sum of his pay in the running pay band and grade pay - Rs.20340/- comes to Rs.610.20 and it shall be rounded off to Rs.610/- only and as such the objection raised by the Joint Director (Pension), Jodhpur is correct and as per provisions of the Rule 13 of R.C.S. (R.P.) Rules, 2008 and illustration No. 4 given in Explanatory Memorandum to the aforesaid rules.

It is requested that similar other cases may also be reviewed and decided as per rules.
