**Subject : Permission for exercise of option / re-option under the Rajasthan Civil Services (Revised Pay) Rules, 2008.**

The Rajasthan Civil Services (Revised Pay) Rules, 2008 have been promulgated with effect from 01.09.2006 vide Finance Department Notification No. F.11(7)FD(Rules)/2008 dated 12.09.2008. The Rule 10 and 11 of these rules provide for exercise of option.

It has been brought to the notice of the Government that some Government servants could not exercise option within the time prescribed under Rule 11(1) and in terms of provisions contained in sub-rule (3)(i) of Rule 11, they were deemed to have exercised option for revised pay scales, 2008 w.e.f. 01.09.2006, which might result in a disadvantageous position. Likewise some of the Government servants have exercised option incorrectly without understanding the proper implications of the rules governing fixation of pay and exercise of such incorrect option has put them to financial loss.

The matter has been considered sympathetically and it has been decided that all Government servants may be permitted to exercise option / re-option under Rule 10 and 11 of the aforesaid rules upto 31<sup>st</sup> March, 2009.
