**Subject :- Rajasthan Civil Services (Revised Pay) Rules, 2008 -
Schedule-II-Special Allowance / Special Pay.**


In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan is pleased to make the following rules to amend further the Rajasthan Civil Services (Revised Pay) Rules, 2008, namely-

1. These rules may be called the Rajasthan Civil Services (Revised Pay) (Fourth Amendment) Rules, 2009.
2. They shall be deemed to have come into force with effect from 01.09.2006 except where otherwise specifically provided.
3. In the said rules - in Schedule -II -
 - (i) under heading "Medical Department - (ii) Collegiate Branch" after the existing entry at S.No. 11, the following new entry at S. No.12 shall be inserted, namely: -
