ORDER

In compliance of decision taken in the Board of Investment meeting dated 14.02.2026 and in exercise of the powers conferred under section 5 of the Rajasthan Investment Promotion Scheme-2024, (hereinafter referred to as "the Scheme") and subject to conditions as enumerated in this Order, the State Government hereby orders the following customized package (hereinafter referred to as "the package"), in favour of M/s Honda Motorcycle & Scooter India Pvt. Ltd. (HMSI) (hereinafter referred to as "the enterprise"), for expansion of manufacturing facility of 2-Wheelers, Parts & Components thereof in Tapukara Industrial Area, District Khairthal – Tijara, Rajasthan :

1. Eligibility for the package. - The enterprise shall be eligible to avail the benefits provided under the package on fulfillment of the following conditions, namely:-

- (i) The enterprise shall fulfill all the conditions of the package, including the eligibility requirements specified under the Scheme, unless otherwise stated in the package.
- (ii) The enterprise shall undertake expansion of its manufacturing facility for 2-wheelers and their parts & components in Tapukara Industrial Area, District Khairthal-Tijara, and shall.-
 - (a) make a minimum investment of Rs. 1500 Crores; and
 - (b) provide employment to 1900 persons (direct 1300 & indirect 600).
- (iii) The enterprise shall commence the commercial production during the operative period of the Scheme.
- (iv) The enterprise shall not be eligible to claim benefit of any subsidy under any other Scheme of the State Government for this project.

2. Benefits Under the Package:

S. No.	Nature of benefit	Benefits Under the package
1.	Asset Creation Incentive (ACI)	<ol style="list-style-type: none">(i) 1.65% of the Net Sales Turnover as Turnover Linked Incentive (TLI) to be disbursed for 10 years as Asset Creation Incentive (ACI).(ii) Additional 10% of the TLI as recommended in the package, as Thrust Booster (would be within the annual ceiling limit).(iii) Additional 15% of the ACI as Employment Booster (would be within the annual ceiling limit) on fulfilling the eligibility conditions.(iv) Additional 10% of the TLI as recommended in the package, as a customization of the asset creation incentive (would be over and above the annual ceiling limit).

2.	Exemptions	100% Electricity duty exemption for 7 years
3.	Other Benefits	Other benefits, shall be available to the enterprise under the provisions of the Scheme subject to fulfillment of eligibility conditions.

3. Terms & Conditions. –

The benefits under this package shall be available on the condition that the enterprise shall make a minimum investment of Rs. 1500 Crores and provide employment to 1900 persons (direct 1300 & indirect 600).

However, if the enterprise fails to fulfill the conditions of minimum investment and employment as provided above within the operative period of the Scheme, the benefits of customized package shall be recovered along with interest as provided in the Scheme by the concerned department.

4. Applicability of the provisions of the Scheme. -

Subject to the provisions of the package, all the provisions of the Scheme shall apply *mutatis mutandis*.

5. Redressal of grievances related to implementation of the package. -

Any grievance related to implementation of this order shall only be referred to State Empowered Committee as constituted under section 3 of the Rajasthan Enterprises Single Window Enabling and Clearance Act, 2011 (Act No.7 of 2011), through its nodal agency. The decision of the said Committee shall be final.
