ORDER

In compliance of decision taken in the Board of Investment meeting dated 14.02.2026 and in exercise of the powers conferred under clause 12 of the Rajasthan Investment Promotion Scheme-2022, (hereinafter referred to as "the Scheme") and subject to conditions as enumerated in this Order, the State Government hereby orders the following customized package (hereinafter referred to as "the package"), in favour of M/s Sangam India Ltd. alongwith its cluster units (hereinafter referred to as "the enterprise"), for expansion of cluster units for spinning, weaving and denim manufacturing at Bhilwara district in the State.-

1. Eligibility for the package. - The enterprise shall be eligible to avail the benefits provided under the package on fulfillment of the following conditions, namely:-

(i) The enterprise shall fulfill all the conditions of the package (as a Group considering as one investment), including the eligibility requirements specified under the Scheme, unless otherwise stated in the package.

(ii) The details of the projects of the enterprise are as follows:-

(iii) The enterprise shall make expansion of cluster units of spinning, weaving and denim manufacturing in Bhilwara, Rajasthan and shall.-

(a) make a minimum investment of Rs. 755.41 Crore with an EFCI of Rs. 548.01 Crore; and

(b) provide employment to 751 persons (Direct-620 persons and Indirect- 131 persons).

(iv) The date of commercial production shall be as per point number (ii) of the table given above.

(v) The enterprise shall not be eligible to claim benefit of any subsidy under any other Scheme of the State Government for this project.

2. Benefits Under the Package:-

The enterprise is eligible for standard benefits of the scheme as a Group considering as one investment. All applications under these projects may be filed under the **Rajasthan Investment Promotion Scheme-2022.**

3. Terms & Conditions. -

The benefits under this package shall be available on the following conditions :-

(i) The enterprise shall make a minimum investment of Rs. 755.41 Crore with an Eligible Fixed Capital Investment (EFCI) of Rs. 548 Crore; and

(ii) Provide employment to 751 persons (Direct-620 persons and Indirect- 131 persons).

However, if the enterprise has already made the investment and generated employment, or has already commenced commercial production as enumerated in clause 1(ii) above, then all details regarding investment, employment, and commencement of commercial production, etc., shall be verified with evidence at the level of Screening Committee constituted under the scheme. If the enterprise fails to fulfill the conditions or fails to verify the details as above, the benefits of the customized package shall not be granted, and if already granted, shall be recovered along with interest, as provided in the Scheme, by the concerned department.


4. Applicability of the provisions of the Scheme. -

Subject to the provisions of the package, all the provisions of the Scheme shall apply *mutatis mutandis*.

5. Redressal of grievances related to implementation of the package. -

Any grievance related to implementation of this order shall only be referred to State Empowered Committee as constituted under section 3 of the Rajasthan Enterprises Single Window Enabling and Clearance Act, 2011 (Act No.7 of 2011), through its nodal agency. The decision of the said Committee shall be final.”


