ORDER

No. F. 12 (32) FD/Tax/2024-Pt-IV-05

Jaipur, Dated: 18.06.2026

In exercise of the powers conferred by sub-section 7.3.1 of the Rajasthan Investment Promotion Scheme-2024 (hereinafter referred to as "the Scheme"), the State Government being of the opinion that it is expedient in the public interest so to do, hereby modifies the Scheme by making the following amendments, with immediate effect, namely:-

AMENDMENTS

- 1. Amendment in Section 2:-** In the existing Sub-Section 2.2, the following expression shall be substituted, namely,-
"A unit that invests and commences commercial operations during the operative period of this Policy shall be eligible to avail benefits exclusively under this Policy. However, this shall not apply to units which have received any entitlement certificates or availed any benefits pre-commencement of commercial operations under any previous RIPS unless otherwise specified in the scheme."
- 2. Amendment in Section 6:-** In the existing Sub-Section 6.1 (Phasing & Telescoping), bullet point no. 4 shall be substituted by the following expression, namely,-
"• In respect to investments with pre-declared phases, where date of commencement of commercial operations of any phase extends beyond the operative period of the Policy, such phase(s) can be completed within a maximum period of two (2) years from the completion of the operative period of the scheme, provided that at least fifty percent (50%) of the total proposed investment in such phase(s) has been made during the operative period of the scheme. Eligible units shall be entitled to avail the incentives for the full tenure as prescribed under the relevant incentive package."
- 3. Amendment in Sub-Section 9.1.3:-** In Sub-Section 9.1.3, definition of "Ethanol" as at S.No. 36 shall be substituted by the following, namely,-
Ethanol means ethanol produced in an eligible manufacturing unit for supply to Oil Marketing Companies (OMCs) for blending programmers and / or for industrial use, in accordance with applicable Government of India guidelines and applicable laws and includes anhydrous and hydrous ethanol."
