## NOTIFICATION

In exercise of the powers conferred by sub-section (1) of section 9 of the Rajasthan Stamp Act, 1998 (Act No. 14 of 1999) and in supersession of this department's notification number F.2(42)FD/Tax/2009-100 dated 14.10.2024, the State Government being satisfied that it is necessary to do so in the public interest, hereby orders that the stamp duty chargeable on the following instruments of loan to be executed upto 31.03.2030 shall be remitted:-

- Instruments of loan agreements for restructuring of the existing loans as well as for
  fresh loans to be executed by any Government company, corporation, society of the
  Rajasthan Government or any development authority, municipality or urban
  improvement trust constituted or established by or under the Act enacted by the
  Rajasthan State Legislature with Banks or Financial Institutions for the purpose of
  public service or in state interest; and
- 2. Instruments of loan executed by the Rajasthan State Power Finance and Financial Services Corporation Limited in favour of the any Government company, corporation, society of the Rajasthan Government or any development authority, municipality or urban improvement trust constituted or established by or under the Act enacted by the Rajasthan State Legislature.

Stamp duty already paid shall not be refunded.
