**Circular**

**Sub: Operational guidelines for SNA-SPARSH (Just-in-Time) System**

**Ref: Ministry of Finance, Department of Expenditure, Government of India  
letter No. F.44(1)/PF-S/2026-27 (CAPEX) dated 27.03.2026**

With reference to the guidelines issued by the Government of India regarding *Special Assistance to States for Capital Investment (SASCI) 2026-27*, the State shall be eligible for an incentive of up to Rs. 450 Crore, subject to fulfilment of the qualifying criteria and milestones specified below:

**1. On-boarding of CSS on SNA-SPARSH**

All Centrally Sponsored Schemes (CSS) implemented in the State shall be mandatorily on-boarded on the SNA-SPARSH platform. On-boarding shall be deemed complete only upon execution of at least one transaction under each State Linked Scheme (SLS).

The list of SLSs where (i) Mother Sanction (MS) has not been issued by the Line Ministry, or (ii) MS has been issued but no expenditure has been incurred during FY 2025-26, is enclosed at **Annexure-A**.

All concerned departments shall:

- Liaise with their respective Line Ministries to obtain pending Mother Sanctions (MS), and
- Ensure execution of at least one transaction under each SLS at the earliest.

**2. Aadhaar-based DBT Implementation**

All schemes having a Direct Benefit Transfer (DBT) component shall mandatorily implement Aadhaar-based DBT in coordination with RBI and NPCI. At least one successful transaction under each SLS must be executed through Aadhaar-based DBT mode.

The list of SLSs where DBT components exist but no transaction has yet been executed through DBT mode is enclosed at **Annexure-B**.

Concerned departments shall coordinate with their respective Line Ministries to operationalize DBT payments and obtain necessary clarifications, if any.

**3. Refund of Unspent Balances**

All departments shall ensure that the Central share of unspent balances lying in SNA accounts of all CSS is refunded, after proper on-boarding on SNA-SPARSH, to the Consolidated Fund of India (CFI) in accordance with this Department's circular dated 07.05.2024.

It is clarified that an SLS shall be treated as on-boarded on SNA-SPARSH upon:

- Opening of its drawing account in RBI, and
- Issuance of Mother Sanction (MS) by the concerned Ministry.

Further, any unspent funds lying in the State Treasury shall be:

- Transferred to the respective SNA account, or
- Refunded to the Consolidated Fund of India (CFI).

All departments shall ensure reconciliation of accounts and reduction of balances to **zero** without delay.

**4. Deposit of Interest from SNA Accounts**

The Central share as well as State share of interest accrued in SNA accounts shall be deposited into the Consolidated Fund of India (CFI) and the Consolidated Fund of the State (CFS), respectively, in accordance with this Department's circular dated 14.03.2024. All departments shall ensure timely deposit **of interest**.

All Administrative Departments are requested to ensure compliance with the above instructions on priority, as the total incentive pool for all States is limited and will be awarded on a first-compliance basis to a limited number of States meeting the prescribed criteria; accordingly, all departments are further requested to ensure completion of the above requirements within 30 days of issuance of this circular.
